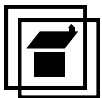


5120.1 HIGH SCHOOL ASSIGNMENTS

Pursuant to the State regulations and existing mandates concerning the sending-receiving district relationship between the Bradley Beach Board of Education and the Asbury Park and Neptune High Schools, the following procedures shall be used as a student selection process. This process gives equal treatment to all children.

1. The 93% Asbury Park High School and 7% Neptune High School attendance shall be based upon:
 - a. The number of students in Grade 8 at Bradley Beach School on March 1 of each year, plus
 - b. The number of Bradley Beach students attending other elementary schools.
2. The Superintendent shall determine by March 1 the number of students needed to attend each receiving school so as to comply with the mandated ratio.
3. Requests for preferential selection will be accepted by the Board of Education between October 1 and February 1 of the graduating year of the 8th grade class.
4. As soon as feasible after February 1, a drawing will take place to establish precedence. This drawing is to be done by a person who shall not be a member or employee of the Board of Education.
5. At such point when the ratio of assignment is met for one high school, all other 8th grade students shall be assigned to the remaining high school.
6. Once a student has been assigned to a given high school, he/she is not at liberty to transfer to the other receiving school without the express consent of the Board.
7. If a student has been assigned to either receiving school and chooses to attend other schools, the original assignment shall continue throughout the student's high school education.



8. Tuition cost for children attending the Asbury Park or Neptune High Schools according to Board policy will be assumed by the Board, providing said children are legal residents of Bradley Beach.
9. Application to Red Bank Regional High School Performing Arts programs is allowed during the 8th grade year for grade 9 September enrollment; applicants are selected by Red Bank Regional High School according to criteria determined by the Red Bank Regional High Performing Arts programs.
10. Tuition costs for students attending Red Bank Regional High School Performing Arts Program in accordance with Board of Education policy will be assumed by the Board, providing such students are legal residents of Bradley Beach and meet the requirements of this policy.
11. Application to the Monmouth County Vocational School Program (MCVSP) or the Academy Charter High School is allowed during the 8th grade year for grade 9 September enrollment; applicants are selected by MCVSP or ACHS according to criteria determined by MCVSP or ACHS.
12. Tuition costs for students attending the MCVSP or ACHS in accordance with Board of Education policy will be assumed by the Board, provided such students are legal residents of Bradley Beach and meet requirements of this policy.
13. The application and enrollment of accepted students into the Red Bank Regional High School Performing Arts or to the MCVSP or ACHS, will be allowed only for applicants applying during their 8th grade year who are entering high school as grade 9 students the following September.
14. Only students in grade 8 and only those accepted in the Performing Arts Programs following audition and acceptance by Red Bank Regional High School, will be allowed to enroll in Red Bank Regional High School.
15. "Performing Arts Programs" as defined in this policy, will include only programs in Dance, Vocal, Piano, Drama, Writing, Commercial Art and Computer Technology.
